To Lindfield Residents affected by the Road Closure (part of High Street and Alma Road)

22nd November 2024

NOTICE: High Street Road Closure 5pm to 9:30pm

Lindfield Village Christmas Festival Night – TUESDAY 3rd December 2024

As you may be aware, the High Street from Denmans Lane to Hickmans Lane will be closed to all vehicles between the hours of 5pm and 9.30pm during the Village's Christmas Festival Night (see Traffic Order overleaf).

Unfortunately, this means that for those living in the High Street and Alma Road, you will not be able to drive a vehicle to or from your property during this period. **It would be very helpful if all parked cars could be removed from the High Street by 5pm** so that the stalls can be set up. MSDC's Parking Enforcement Team have been invited to visit the High Street during the afternoon in the period preceding the road closure.

Depending on the direction of intended travel **traffic will be rerouted, either through Compton Road and Denmans Lane, or through Brushes Lane, Dukes Road, Newton Road, Luxford Road and Eastern Road**, for the duration of the road closure and you should be aware that this may include lorries and buses, as well as emergency vehicles. Accordingly, it would be very helpful if residents in those roads could park in such a way as to allow large vehicles to pass through during the period of road closure.

Hopefully this will not cause you too much inconvenience and Lindfield Parish Council, the village shops and street stalls, would like to thank you for your assistance and co-operation during this event; it is very much appreciated.

**LOCAL GOVERNMENT ACT 1972, SECTION 180
TOWN POLICE CLAUSES ACT 1847, SECTION 21**

**MID SUSSEX DISTRICT COUNCIL
(TEMPORARY PROHIBITION OF TRAFFIC ORDER) 2024**

NOTICE IS HEREBY GIVEN that the Mid Sussex District Council, in pursuance of their powers under the above Acts have ordered and directed that as:

High Street, Lindfield

(Lindfield High Street (Alma Road) between Hickmans Lane and Denmans Lane)

will be thronged and liable to be obstructed, that the aforesaid streets, and parts of streets, will be closed to vehicular traffic (including pedal cycles and horses) between the hours of **17:00 hrs to 21:30 hrs Tuesday 3rd December 2024** or such lesser period as may be required for the **Lindfield Village Christmas Festival Night** to take place.

PROVIDED THAT this temporary closure is subject to any direction, which may be given by a police constable in uniform.

Wilful breach of this Order renders offenders liable to a penalty not exceeding Twenty Pounds.
