## **Summary:**

For Noting – MSDC's approval of planning application DM/25/2308 felling a birch tree to ground level, to which PTTC had objected.

## **Background:**

DM/25/2308 Froyls, 125 High Street – Birch Tree Fell to ground level. This application was considered at PTTC 23/9/25 and the response "Lindfield Parish Council (LPC) objects to this application noting that this fine birch tree has a TPO and should be protected accordingly. LPC questions whether it would be appropriate for some minor trimming or pruning to assuage concerns regarding its proximity to property." was submitted to MSDC.

#### **Current Position**

On 30/10/25 MSDC gave permission for the tree to be felled.

The Planning Officer's Delegated Report states:-

"The tree is a mature specimen, located to the front of the property. It is highly visible from the High Street and contributes to the character of the Conservation Area.

The tree has previously been reduced, however, it has now reached maturity. Whilst the tree does not have significant defects, it would appear that there has been some historic soil piling around the base. This has resulted in small areas of loose bark and decay in some areas. There is also evidence of a broken root and possible root movement, most likely exacerbated by the dry summer. Paving slabs and drains has also been damaged by the tree roots, indicating that the roots have moved closer to the gravel surfacing.

A representation has been received, supporting the felling of the tree on the following grounds;

- our lives are blighted by the tree
- there is so much debris from the tree that we cannot open our back door or windows
- the patio must be swept daily- the height of the tree poses a threat to the back of the house
- the tree is at worst a danger and at best, a nuisance

With regard to the parish council comments, the tree has previously been reduced and birch trees do not prune successfuly. It is not considered that there is any work which could be carried out to the tree which would make it safer. Whilst the tree is of undoubted amenity value, it is also a mature specimen, coming to the end of its life.

This is a balanced case and, while the tree is not currently a high risk, it is likely to become so. Bearing in mind its limited lifespan and defects which are likely to become more significant as time passes, and its high target area, it is considered that a pragmatic approach is required.

On balance, it is considered favourable to replace the tree with a native specimen which has some longevity for the future."

## Summary

No expenditure to date. **2026-27 Budget discussions** for PTTC to commence 14<sup>th</sup> October 2025, **to agree proposals 4<sup>th</sup> November 2025** for consideration by F&GP. Proposal to 'vire' £250 from current year's RTPI budget to support TTWG 2025 25mph speed limit publicity.

With the District Plan currently under (critical) scrutiny, the government's plans for increased housebuilding, and devolution proposals, it would appear more likely that the Planning Reserve may be required in the foreseeable future.

The 2025/7 budget proposal includes £400 towards ancillary costs for PTTC, particularly publicity for the TTWG 2025 20 mph speed limit proposals. No other projects have been identified for which a budget, as opposed to reserve, will be required in the next financial year.




